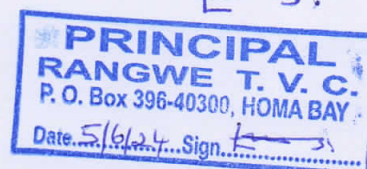

- The registration application forms if not filled out completely and submitted in the prescribed manners will not be considered. All the documents that form part of the proposal must be written in English.

**General experience:** The applicant shall meet the following minimum criteria:

- i. **The audited accounts:** The supplier's financial condition will be determined by the last two years audited financial statement submitted with the application documents as well as letters of reference from previous performances. Potential suppliers/contractors will be prequalified on the satisfactory information given.

Special consideration will be given to the financial resources available as working capital, considering the number of uncompleted orders on contract and now in progress. Potential bidders shall provide evidence to execute the contract.

- ii. **Litigation history:** the applicant should provide accurate information about litigation or arbitration resulting from contracts completed or uncompleted under its execution.
- iii. **Past Performance:** will be given due to consideration in registration of suppliers. Letters of reference from past customers should be included.
- iv. **Business premises:** The firm must have a fixed Business premises and must be registered in Kenya with certificate of Registration, Incorporation/Memorandum, and articles of Association. Copies must be attached.
